### HOW WE MET

Barry's presentation caused us to address an important question - what type of Kingdom impact will we make with our estate?

After prayer and discussion, we felt a call to do more than simply leave everything to the children. God had blessed us and we needed to be faithful to use that blessing to spread the Gospel. We therefore decided to divide our estate into three parts, not two, treating God's Work as an additional child.

It was at this point that we were connected with PhilanthroCorp, a partner of The Baptist Foundation of Alabama. As an attorney, I know too well the problems that can arise when parents do a poor job of handling their estate. After a few phone conferences with our PhilanthroCorp representative, they had showed us exactly how to carry out the plan we had outlined. With their expertise in estate planning, they were actually able to dedicate certain taxable assets to the "Kingdom" portion of our estate so that the net inheritance to Laine and Graham was virtually the same as when we had simply split everything into only two shares. We could not have been more satisfied with the expert guidance they provided.
